Newly Admitted Students

SUMMER/FALL

MAY 1

Decision Made and Deposit In

- Visit MyFinancialAid@Naz to accept or decline awards.
- Check Documents and Messages in MyFinancialAid@Naz for any missing information needed.
- Notify Financial Aid Office of any private outside scholarships received.

JUNE 30

- Submit missing financial documents, if needed.
- Complete Entrance Counseling and Master promissory Note (MPN) if using Federal Loans, www.studentloans.gov.
- Student adds parent(s) as Authorized Proxy at NazNet Self Service. This allows parents to view bills and enables detailed discussions with Financial Aid and Student Accounts.

JULY

- Student Accounts office will email student to notify that fall semester bill is available online.
- View online bill at NazNet Self Service.
- Review payment options in letter sent from the Financial Aid Office which includes Nazareth Payment Plan, Federal Parent Plus Loan, and/or Private student loan.
- Apply for additional loans after viewing bill and/or set up payment plan.

AUGUST

• Fall bills due (see Student Accounts for exact billing dates).

• Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. **If there is a pending refund** (a negative balance) that is not needed, contact financial aid office to reduce loan amount.

OCTOBER

• FAFSA available. Completed annually if receiving need based aid and/or using federal loans.

NOVEMBER

• Student Accounts office will email student to notify that spring semester bill is available online.

DECEMBER

• Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. If there is a pending refund (a negative balance) that is not needed, contact financial aid office to reduce loan amount.

SPRING

JANUARY

- Spring bills due (see Student Accounts for exact billing dates).
- Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. If there is a pending refund (a negative balance) that is not needed, contact financial aid office to reduce loan amount.

MARCH 1

• FAFSA submission due for next academic year.

- Check MyFinancialAid@Naz for any additional financial aid documents needed after filing FAFSA.
- SPARK recipients- all outstanding financial aid documents must be received by March 1.

APRIL 1

• Deadline for any additional financial aid documents requested after filing FAFSA.

MAY

• Summer Session financial aid packages for view; students alerted through Nazareth email.

JUNE

• Fall/Spring financial aid packages ready for view starting after spring grades are posted; students alerted through Nazareth email.

JULY

- Fall bill generated (see Student Accounts for exact billing dates).
- Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. If there is a pending refund (a negative balance) that is not needed, contact financial aid office to reduce loan amount.
