

# FINANCIAL AID TIMELINE

## Returning Students

### FALL

#### OCTOBER 1

- FAFSA available. Complete annually if receiving need-based aid and/or using Federal Loans.

- Student adds parent(s) as Authorized Proxy at NazNet Self Service, if not already done so.

**This allows parents to view bills and enables detailed discussions with Financial Aid and Student Accounts.**

#### NOVEMBER

- Student Accounts office will email student to notify that spring semester bill is available online.

#### DECEMBER

- Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. **If there is a pending refund (a negative balance) that is not needed, contact financial aid office to reduce loan amount.**

### SPRING/SUMMER

#### JANUARY

- Spring bills due (see Student Accounts for exact billing dates).

#### MARCH 1

- **FAFSA submission due for next academic year.**
- Check Documents and Messages in MyFinancialAid@Naz for any missing information needed after filing FAFSA.
- **SPARK recipients- all outstanding financial aid documents must be received by March 1.**

#### APRIL

- Summer A/B Session financial aid packages available for view; students alerted through Nazareth email.

- Student Accounts office will email student to notify that Summer A semester bill is available online.

#### APRIL 1

- **Deadline for any additional financial aid documents requested after filing the FAFSA.**

#### MAY

- Summer A/B Session financial aid packages available for view; students alerted through Nazareth email.

- Summer A bills due (see Student Accounts for exact billing dates).

- Student Accounts office will email student to notify that Summer B semester bill is available online.

- Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. **If there is a pending refund (a negative balance) that is not needed, contact financial aid office to reduce loan amount.**

- Apply for additional loans after viewing bill if necessary for Summer Session(s).

#### JUNE

- Fall/Spring financial aid packages ready for view starting after spring grades are posted; students alerted through Nazareth email.

- Summer B bills due (see Student Accounts for exact billing dates).

## • JULY

- Fall bill generated (see Student Accounts for exact billing dates).
- Review online bill at NazNet Self Service; if using Federal Parent Plus Loan and/or Private student loans to cover balance, verify loan amount covers all charges. **If there is a pending refund (a negative balance) that is not needed, contact financial aid office to reduce loan amount.**
- Apply for additional loans after viewing bill and/or set up payment plan for Fall semester.

## • AUGUST

- Fall bills due (see Student Accounts for exact billing dates).
