Payroll Deduction Information

Payroll deduction is an easy way to make an annual donation through installments. Your contributions each pay period make a meaningful difference throughout the year!

- Deductions can be changed or terminated at any time.
- To change or end your deduction, please send a written notification to the Advancement Office.
- Deductions will commence within two weeks after your pledge has been processed.
- All bi-weekly payments will be acknowledged with an annual receipt in January of the following year.
- Due to the complexities of payroll deduction processing and the amount of personnel involved, the minimum payroll deduction, per pay period, is \$5.
