REMUNERATION GUIDELINES

We appreciate your collaboration with us, in support of teacher education at Nazareth College. We truly value your commitment and your contribution to our profession. Therefore, we offer a remuneration as a token of our appreciation. The Nazareth College School of Education offers the following options for remuneration:

OPTION 1: CASH HONORARIUM

- This honorarium is a check made payable to the School-Based Teacher Educator.
- The check amount varies based on the length of the candidate's placement and whether you share supervision with another teacher:
 - Half-Semester Placement: \$200
 - Full Semester Placement: \$400
 - If you share the supervision of the teacher candidate with another SBTE (such as a co-teacher), you will receive half of the remuneration amount listed above based on the length of the placement.

OPTION 2: TUITION WAIVER - PROFESSIONAL DEVELOPMENT

- This is a credit tuition waiver for undergraduate and graduate courses at Nazareth College.
- The amount waived varies based on the length of the candidate's placement and whether you share supervision with another teacher:
 - Half Semester Placement: a one and one-half credit tuition waiver
 - Full Semester Placement: three credit tuition waiver.
 - If you share the supervision of the teacher candidate with another SBTE (such as a co-teacher) for the full semester you are eligible to receive half of the remuneration amount listed above based on the length of the placement.
 - Note, this option is not available for SBTEs who share the supervision of a teacher candidate for a half semester placement.
- The tuition waiver is **not transferable**.
- The tuition waiver must be **used any one of the next nine consecutive registration periods** and may not be extended, for any reason, beyond this time-period. (Please note: Summer Session I and II are considered one semester/registration period).
- Active waivers need to be presented at the time of registration in order to be applied to the current student bill.

REMUNERATION TIMELINE:

- Approximately **two weeks before the candidate's placement comes to an end**, you will receive an email with the remuneration guidelines, the remuneration selection form and a W-9 form.
- Please print the remuneration selection form and W-9 and fill it out completely.
 - Note: if you have previously completed a W-9 for Nazareth College you do not need to submit an additional one.
- Please **mail (via the US Postal Service)** the selection form and W-9 to the Office of Clinical Experiences and Partnerships by the **final day of the teacher candidate's placement**.
